

FINAL ORGANIZATION OF THE NCPHS

Our Society will meet to formerly organize at CHARPEX. The meeting will be at 11 AM on Saturday, July 24, at the show. (CHARPEX will be held at the Charlotte Merchandise Mart.) Order of business will include discussion and adoption of society by-laws (copy enclosed with this newsletter for your review before the meeting), establishment of dues, election of officers, appointment of committees, discussion and action upon the report for organization of the study of North Carolina postal history, organization of the journal/newsletter.

All interested in our society should plan to attend the meeting and should examine the enclosed

by-laws beforehand.

PHOTOGRAPHIC DOCUMENTATION OF NORTH CAROLINA COVERS

The committee of photographers appointed at the High Point meeting to record North Carolina Postal History covers will begin operations at the CHARPEX meeting in Charlotte, July 24-25. CHARPEX has graciously allowed the North Carolina Postal History Society to have space where the committee of Steve Jaronski, John Allen, and Vernon Stroupe will copy and photograph covers from members collections.

This first effort will be directed towards recording pre-1866 covers in all categories: manuscripts, pre-stamp, hand stamped, and adhesives. The committee will be especially looking for unlisted post

offices, postal markings, rates, fancy cancels, and unusual usages.

A secondary, but highly desirable, service will be to provide the owners with a source for blackand-white photos and/or color slides that can be used to illustrate articles, slide programs, and identification. The cost of photography will be 'user shared,' that is, the society will pay for the cost of recording covers for use by the society, and the owner will pay a nominal fee for any photos he/she wishes for personal use.

Our photo librarian, Rev. Edgar Seymour, will be the custodian of the finished photography and

records for the society.
